## **OVERSUBSCRIBED SHARE PURCHASE PLAN ISSUE COMPLETED**

Manas Resources Limited (ASX: MSR) refers to its prior announcements in relation to a share purchase plan offer ("SPP") under which a maximum of 200 million shares were made available for subscription by eligible shareholders at \$0.00275 per share. The SPP offer was substantially oversubscribed.

In view of the overwhelming support from shareholders, the Board has exercised its discretion and accepted all valid applications received by the closing date of Friday, 22 July 2016. A total of 491,000,546 shares have been issued for total proceeds of \$1.35 million and an Appendix 3B is attached with respect to this share issue.

Manas's Chief Executive Officer, Philip Reese commented; "*The overwhelming response to the SPP vindicates our decision to acquire the exciting Victoria Gold Project in Tanzania. On behalf of the Board, I wish to thank shareholders for their ongoing support and we look forward to providing further updates in the near future on our due diligence review of the vast database for the Victoria Gold Project and the outcome of our strategic review on the future plans for our assets in the Kyrgyz Republic.*"
